However, the empirical evidence for intergenerational transmission of child maltreatment (ITCM) has been mixed. Although ITCM was found in some studies [6 – 8], other researchers have found no evidence for transmission [1, 9, 10]. Overall, meta-analytic evidence suggests that there is ITCM but that effect sizes are modest [11].

Widom (1989) reported 'intergenerational transmission' to be the 'premier' hypothesis in the child maltreatment field. Current evidence suggests that while some parents who have been abused as children become abusive parents, the majority do not (Kaufman and Zigler 1993).

Childhood maltreatment has intergenerational consequences. In a prospective American study of over 400 mother–child dyads, maternal history of physical abuse was found to predict offspring county court allegations and substantiations of maltreatment in the first 2 years of life (Berlin et al.2011).
